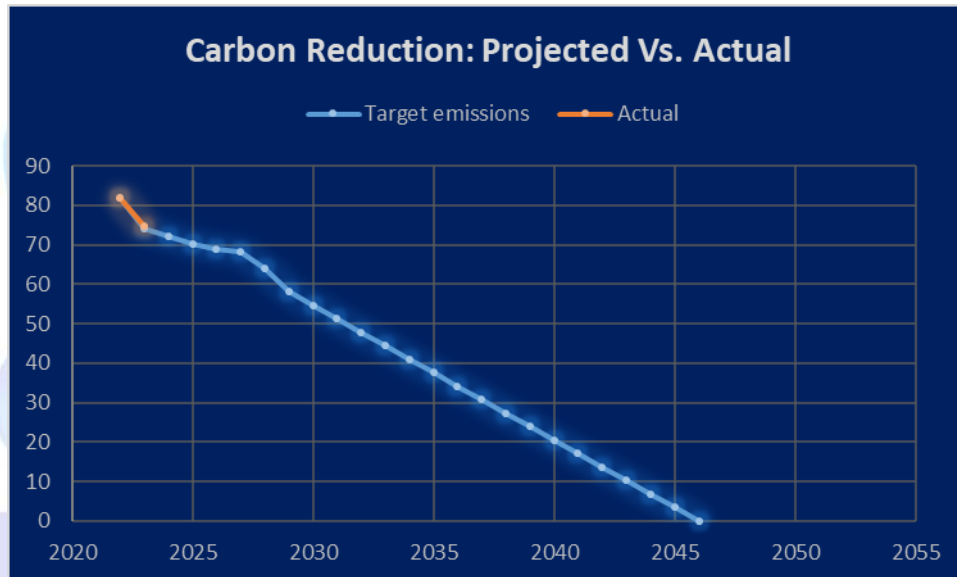

Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to **64.07** tCO₂e by **2028**. This is a reduction of **14%**

Completed Carbon Reduction Initiatives

- Promote greater adoption of video communications to reduce travel.
- Renew the Company's ISO 14001 certification.
- Consolidate the number of Company offices.
- Gifting of surplus office furniture to a carbon neutral company that will re-use and re-home it rather than put in landfill.
- Implementation of energy efficient lights.
- Continue the migration to electric vehicles

Over the next 12 months, it is expected that the following environmental management measures and schemes will be implemented and these will each contribute to a quantifiable carbon emission reduction:

- **Continue to promote greater adoption of video communications to reduce travel (growth in hybrid working across UK businesses has accelerated this).**
- **Renew the Company's ISO 14001 certification.**
- **Continue the migration to electric / hybrid vehicles.**
- **Promote car sharing on business trips / journeys to and from work.**
- **Continue to review office electricity and gas consumption and contracts.**
